

N4MU Terms of Service

1. ACCEPTANCE OF TERMS

N4MU.com and BunkZunk.com is property of HomeStep LLC (herein "N4MU"). N4MU welcomes you. N4MU provides the N4MU Services (defined below) to you subject to the following Terms of Service ("TOS"), which may be updated by us from time to time without notice to you. You can review the most current version of the TOS at any time at: N4MU.COM. By accessing and using the N4MU Services, you accept and agree to be bound by the terms and provision of the TOS. N4MU may also offer other services that are governed by different Terms of Service.

2. DESCRIPTION OF N4MU SERVICES

BunkZunk.com is a module for self-printing and customizing designs for various purposes. Much of the references below, while not limited to, pertain to the N4MU.com Ver 2.8 module due to the ability for Subscribers to publish, post, advertise and communicate public information over the internet and to individual users, arenas and forums.

N4MU, primarily through the N4MU.com (ver 2.8 module), provides users with access to various communications tools which may be accessed through any various medium or device now known or hereafter developed (the "N4MU Services"). You also understand and agree that the N4MU Services may include advertisements and that these advertisements are necessary for N4MU to provide the N4MU Services. You also understand and agree that the N4MU Services may include certain communications from N4MU, such as service announcements, administrative messages and offers, and that these communications are considered part of N4MU membership and you will not be able to opt out of receiving them. Unless explicitly stated otherwise, any new features that augments or enhances the current N4MU Services, including the release of new N4MU properties, shall be subject to the TOS. You understand and agree that the N4MU Services is provided "AS-IS" and that N4MU assumes no responsibility for the timeliness, deletion, mis-delivery or failure to store any user communications or personalization settings. You are responsible for obtaining access to the N4MU Services, and that access may involve third-party fees (such as Internet service provider or airtime charges). You are responsible for those fees, including those fees associated with the display or delivery of advertisements. In addition, you must provide and are responsible for all equipment necessary to access the N4MU Services.

3. YOUR REGISTRATION OBLIGATIONS

In consideration for your paid fee(s) and of your use of the N4MU Services, you represent that you are of legal age to form a binding contract and are not a person barred from receiving the N4MU Services under the laws of the United States or other applicable jurisdiction. You also agree to: (a) provide true, accurate, current and complete information about yourself as prompted by the N4MU Service's registration form (the "Registration Data") and (b) maintain and promptly update the Registration Data to keep it true, accurate, current and complete. If you provide any information that is untrue, inaccurate, not current or incomplete, or N4MU has reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, N4MU has the right to suspend or terminate your account and refuse any and all current or future use of the N4MU Services (or any portion thereof).

4. N4MU PRIVACY POLICY

Registration Data and certain other information about you are subject to our applicable privacy policy. For more information, see the full N4MU Privacy Policy at N4MU.com. You understand that through your use of the N4MU Services you consent to the collection and use (as set forth in the applicable privacy policy) of this information, including the transfer of this information to the United States and/or other countries for storage, processing and use by N4MU and its affiliates.

5. MEMBER ACCOUNT, PASSWORD AND SECURITY

You will receive an ID# and password upon completing the N4MU Service's registration process. You are responsible for maintaining the confidentiality of the password and account and are fully responsible for all activities that occur under your password or account. You agree to (a) immediately notify N4MU of any unauthorized use of your password or account or any other breach of security, and (b) ensure that you exit from your account at the end of each session. N4MU cannot and will not be liable for any loss or damage arising from your failure to comply with this Section 5.

6. MEMBER CONDUCT

You understand that all information, data, text, messages, or other materials ("Content"), whether publicly posted or privately transmitted, are the sole responsibility of the person from whom such Content originated. This means that you, and not N4MU, are entirely responsible for all Content that you post, email, transmit or otherwise make available via the N4MU Services. N4MU does not control the Content posted via the N4MU Services and, as such, does not guarantee the accuracy, integrity or quality of such Content. You understand that by using the N4MU Services, you may be exposed to Content that is offensive, indecent or objectionable. Under no circumstances will N4MU be liable in any way for any Content, including, but not limited to, any errors or omissions in any Content, or any loss or damage of any kind incurred as a result of the use of any Content posted, emailed, transmitted or otherwise made available via the N4MU Services.

You agree to not use the N4MU Services to:

- i. intentionally or unintentionally violate any applicable local, state, national or international law, including, but not limited to, regulations promulgated by the U.S. Securities and Exchange Commission, any rules of any national or other securities exchange, including, without limitation, the New York Stock Exchange, the American Stock Exchange or the NASDAQ, and any regulations having the force of law;
- j. provide material support or resources (or to conceal or disguise the nature, location, source, or ownership of material support or resources) to any organization(s) designated by the United States government as a foreign terrorist organization pursuant to section 219 of the Immigration and Nationality Act;
- k. "stalk" or otherwise harass another; and/or
- l. collect or store personal data about other users in connection with the prohibited conduct and activities set forth in paragraphs a through m above.

You acknowledge that N4MU may or may not pre-screen Content, but that N4MU and its designees shall have the right (but not the obligation) in their sole discretion to pre-screen, refuse, or remove any Content that is available via the N4MU Services. 11. INDEMNITY

You agree to indemnify and hold N4MU and its subsidiaries, affiliates, officers, agents, employees, partners and licensors harmless from any claim or demand, including reasonable attorneys' fees, made by any third party due to or arising out of Content you submit, post, transmit, modify or otherwise make available through the N4MU Services, your use of the N4MU Services, your connection to the N4MU Services, your violation of the TOS, or your violation of any rights of another.

12. NO COMMERCIAL REUSE OF N4MU SERVICES

Such notices may not be received if you violate this TOS by accessing the N4MU Services in an unauthorized manner. Your agreement to this TOS constitutes your agreement that you are deemed to have received any and all notices that would have been delivered had you accessed the N4MU Services in an authorized manner.

20. TRADEMARK INFORMATION

You agree that all of N4MU's trademarks, trade names, service marks, artwork designs and other N4MU logos and brand features, and product and service names are trademarks and the property of HomeStep LLC. (the "N4MU Marks"). Without HomeStep LLC's prior permission, you agree not to display or use in any manner the N4MU Marks.

21. NOTICE AND PROCEDURE FOR MAKING CLAIMS OF COPYRIGHT OR INTELLECTUAL PROPERTY INFRINGEMENT

N4MU respects the intellectual property of others, and we ask our users to do the same. N4MU may, in appropriate circumstances and at its discretion, disable and/or terminate the accounts of users who may be repeat infringers. If you believe that your work has been copied in a way that constitutes copyright infringement, or your intellectual property rights have been otherwise violated, please provide N4MU's Copyright Agent the following information:

- a. an electronic or physical signature of the person authorized to act on behalf of the owner of the copyright or other intellectual property interest;
- b. a description of the copyrighted work or other intellectual property that you claim has been infringed;
- c. a description of where the material that you claim is infringing is located on the site;
- d. your address, telephone number, and email address;
- e. a statement by you that you have a good faith belief that the disputed use is not authorized by the copyright owner, its agent, or the law;
- f. a statement by you, made under penalty of perjury, that the above information in your notice is accurate and that you are the copyright or intellectual property owner or authorized to act on the copyright or intellectual property owner's behalf.

22. GENERAL INFORMATION

Entire Agreement. The TOS constitutes the entire agreement between you and N4MU and governs your use of the N4MU Services, superseding any prior version of this TOS between you and N4MU with respect to the N4MU Services. You also may be subject to additional terms and conditions that may apply when you use or purchase certain other N4MU services, affiliate services, third-party content or third-party software.

Choice of Law and Forum. You and N4MU each agree that the TOS and the relationship between the parties shall be governed by the laws of the State of New York without regard to its conflict of law provisions and that any and all claims, causes of action or disputes (regardless of theory) arising out of or relating to the TOS, or the relationship between you and N4MU, shall be brought exclusively in the courts located in the county of Nassau, New York or the U.S. District Court for the Northern District of New York. You and N4MU agree to submit to the personal jurisdiction of the courts located within the county of Nassau, New York or the Northern District of New York, and agree to waive any and all objections to the exercise of jurisdiction over the parties by such courts and to venue in such courts.

Waiver and Severability of Terms. The failure of N4MU to exercise or enforce any right or provision of the TOS shall not constitute a waiver of such right or provision. If any provision of the TOS is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the parties' intentions as reflected in the provision, and the other provisions of the TOS remain in full force and effect.

No Right of Survivorship and Non-Transferability. You agree that your N4MU account is non-transferable and any rights to your N4MU ID or contents within your account terminate upon your death. Upon receipt of a copy of a death certificate, your account may be terminated and all contents therein permanently deleted.

Statute of Limitations. You agree that regardless of any statute or law to the contrary, any claim or cause of action arising out of or related to use of the N4MU Services or the TOS must be filed within one (1) year after such claim or cause of action arose or be forever barred.

23. DUE TO THE SETUP PROCESS, NO REFUNDS WILL BE GIVEN AFTER REGISTRATION FOR ANY UNUSED PORTION OF ANY N4MU ACCOUNT OR SUBSCRIPTION CONTRACT.

24. N4MU RESERVES THE RIGHT TO CANCEL ANY SUBSCRIPTION OR SUBSCRIPTIONS FOR MISUSE, MISREPRESENTATION, OR ANY ILLEGAL USE. THE USE OF PERSONAL, PRIVATE, CONFIDENTIAL OR INFORMATION DEEMED INAPPROPRIATE FOR MINORS OR THE GENERAL PUBLIC WILL NOT BE TOLERATED AND WILL RESULT IN THE TERMINATION OF SUCH ACCOUNTS AND SUBSCRIPTIONS WITHOUT REFUND.

26. N4MU AND HOMESTEP LLC ADVISES AND CLAIMS THAT THE N4MU SYSTEM IS NOT TO BE USED FOR THE DISTRIBUTION, PROMOTION OR PUBLICATION OF PRIVATE, PERSONAL, CONFIDENTIAL OR PRIVILEGED INFORMATION IN ANY WAY.
